## Decisions made by the Executive Council, with agreed actions and responsibility for those actions.

The decisions and actions are numbered according to the agenda of the meeting of the Council and Commission Chairs.

The Executive Council received the recommendations of the meeting of the Council and Commission Chairs, made decisions on those recommendations, and assigned responsibility for actions as set out below

### 1. Welcome by President

Resolution:

*IUPAP receives with regret the resignation of President Kennedy Reed. In accepting this resignation, IUPAP records its appreciation of his 17 fruitful years of service for IUPAP, first in C13, then representing IUPAP in ICSU and culminating in his term as President Designate and President. We wish him well in his future, and will find ways in which IUPAP can be a part of that.*

*Noting that, if the President is unable to serve the President Designate shall assume the Presidency, we welcome Michel Spiro as the President of IUPAP.*

Kennedy Reed has served IUPAP for seventeen years.

He received his PhD from the University of Nebraska in 1976 in theoretical atomic physics and is known for his work on electron atom and atom collisions, particularly those relevant to high energy and high density plasmas. He retired two years ago from the Atomic Theory Group at the Lawrence Livermore Lab, where he was working on physics of interest to the laser fusion program. He has been recognised for his work with, and co-founding of, the National Physical Science Consortium which provides fellowship for women and minority PhD graduates, by the 2009 Presidential Award for excellence in Science, Physics and Mathematics mentoring. He also received the 2003 John Wheatly award for the promotion of physics research education in Africa.

He started his work with IUPAP as a member of C13 in 2002, and was the Chair of C13 in 2008-2011. He attracted the first ICSU grant with IUPAP received. He was then elected as the IUPAP nominee to the ICSU Executive Board, and in that capacity served on the ICSU committee for their Regional Office for Africa.

He was elected as IUPAP President Designate in 2015 and has been the IUPAP President for the last two years. His work as President was made difficult by his own illness and then the family illness which brought him to the point that he needed to resign. Through this he continued to work as hard as he could for IUPAP. In particular he devoted much energy to establishing the working group on physics and industry, as we will hear later this morning.

We are sad to be losing his talents in this way, and are grateful for the long and fruitful service he has given to us. We wish him strength in the difficult time ahead. He has made an important difference to our Union. In thanks to him we should all work to support and improve IUPAP.

Our statutes say that “if the President is unable to serve the President Designate shall assume the Presidency” I therefore hand the floor to President Michel Spiro.

To,

THE BRAZILIAN AUTHORITIES IN SCIENCE AND TECHNOLOGY

The Executive Council of the International Union of Pure and Applied Physics (IUPAP) took place in LONDON, U.K., from 30 of September to 3rd October 2019. The Executive Council meets with the Chairs of our 20 Commissions and 4 Affiliated Commissions to continue the work of the Union between the meetings of our General Assembly.

We learned from physicists working in Brazil, as well as from the President of the Brazilian Physics Society, that Brazil is suffering significant cuts to its science budget, and that this is happening after a long period of an expanding scientific research effort.

Many of our 64 member countries have also experienced economic developments that pushed their governments to make significant cuts to the science budget of their countries. And from those experiences we have learned that it takes a significant period of time to create excellent scientific institutions - the time involved is decades, not years. But the time it takes to disrupt these institutions is much shorter - perhaps one year - when they are hit by dramatic budget cuts. As a result, the skills which have been developed are lost, and the flow of innovation from scientific research to industry is cut off. Young scientists who had hoped to make a scientific career in their home country will go elsewhere, because the market for their talent is world-wide. Due to this disruption to their careers, they will be very reluctant to return to their home country, fearing that it will happen again.

After the expansion of the scientific research effort, in the early 2000s, that was responsible to bring Brazil as the 13th place of scientific production in the world, the more productive science support in Brazil has now contracted to the extent that many research and academic institutions are having difficulty paying for their basic services and maintenance. The dismantling of internationally renowned research groups and a brain drain involving some of Brazilian best scientists will occur. Scientific research will suffer, and as all economies are ultimately built on the talents of its people, the wider economy will also suffer.

The Executive Council appreciates the serious economic difficulties faced by Brazil. However, it respectfully points out that the severity of the budget cuts, personnel reductions, breach of assumed commitments in research grants, international cooperation and serious restrictions imposed by the government will inhibit recovery from those difficulties, and pleads that you reverse these decisions before even more damage is done, and while there is still a chance of recovery. That will avoid squandering the investment that Brazil has made over many years in its scientific and technological capability.

The Executive Council resolved to write to you to explain the effects that these policies will have on the scientific community in Brazil, and how they will seriously jeopardize the economic future of the country. This letter is the implementation of that resolution. It will be published, together

## 2 Duties of Chairs, from Heidi

### What is going to happen:

Over the 3 year term, Commission Chairs should expect to attend several meetings. There will be several IUPAP specific meetings of IUPAP Commission Chairs and in addition, meetings of individual Commissions and possible meetings of Working Groups for which a Commission is the convening body.

The form IUPAP Chairs meetings last 2-3 days and rotate amongst member countries.

IUPAP will generally cover reasonable travel expenses for the IUPAP Commission Chairs meetings but not for travel to the individual Commission meetings unless a formal request for support is made to the organization.

Different Commissions have different methods of carrying out their business. Typical methods are:

- Phone meetings
- Annual meetings at the major conferences for the field
- Standalone meetings as needed

### The expected schedule for formal IUPAP meetings is:

- An IUPAP General Assembly in the Fall previous to the beginning of the Chair's term.
- A special meeting of Commission Chairs in the first Spring of their term for orientation.
- An annual Fall meeting of the Commission Chairs in years 1 and 2 followed by the General Assembly meeting in the Fall of year 3.

Commission Chairs are expected to prepare a formal report of the activities of their Commission for each Fall meeting. National liaison committees may also require a report. A 3 year report is expected for the General Assembly.

Assuring a smooth transition to the next leadership is important. In most Commissions it is expected but not required, that the Vice Chair or Secretary will be the next Chair. For this reason, the Vice Chair and Secretary (and, if different, the next Chair-Designate) should be included in decisions and correspondence to assure that they are fully aware of the operations of the Commission. The Commission should also be thoughtful in nominating new members and officers to ensure a strong group of future officers.

Each Commission has access to a very small (~1000 EU) annual budget that may be accessed by application to the President and Secretariat. The most common use of these funds is to support the travel of Commission members from developing countries to Commission meetings.

### 3 Freedom of movement of Data

Physics more and more involves international collaborations that share in the construction and operation of common apparatus and analysis of the data that results. Such collaboration is most successful when collaborating scientists have unimpeded access to both the physical apparatus and to the data that has resulted from their efforts. We observe a disturbing trend of restriction of access to facilities, shared data and methods of communication. While nations have legitimate needs to protect their critical facilities and computing systems, they also have a responsibility to find ways to maintain access for international scientific collaborators.
